CIRCULAR

In accordance with the Special Ordinance OS-1 relating to the conduct of Examinations during the Covid-19 pandemic and in partial modification to Circular No.GU/Exam/55/2021/142 dated 19/11/2021 and Circular No.GU/Exam Div/2022/158 dated 13/01/2022 regarding Offline Examinations and as per the decision of the Hon'ble High Court of Bombay at Goa dated 01/02/2022 it has been decided that all the **OFFLINE** Examinations of the General and Professional Programmes scheduled to start on 7th February 2022 onwards shall now be conducted from 16th February 2022 onwards except in the case of Medical Programmes which may start as per schedule in the 1st week of February.

In order to give priority to student safety the following provisions shall be made and followed by all the concerned:

- a) All the SOPs and Covid Prevention Protocols communicated from time to time shall be followed while conducting the examinations.
- b) For Engineering Examinations, to avoid too many students of different branches coming to the concerned Colleges on the same day/time for the examination, their examination time table shall be suitably modified so that number of students attending at any given time is reduced.
- c) For the students who are ill or if any of whose family members are ill/have tested Covid Positive, or for students with any co-morbid condition, separate seating arrangements (isolated) shall be made for each of these categories of students, wherever the College infrastructure permits it. Otherwise, these students may be asked to appear for the Special Examination to be held later on.

d) The provision for the Special Examination as notified by the University vide Circular No.GU/Exam Div/2022/157 dated 13/01/2022 shall remain in force for all students who are unable to appear for the examination.

Deans of Schools/Faculties, and Principals of all Affiliated Colleges are requested to make suitable arrangements for the conduct of these examinations and bring the contents of this circular to the notice of all concerned.
