

CIRCULAR

In accordance with the Special Ordinance OS-1 relating to the conduct of Examinations during the Covid-19 pandemic and in partial modification to Circular No.GU/Exam/55/2021/142 dated 19/11/2021 regarding Offline Examinations and Circular No. GU/Exam-UG/2021/908 and GU/Exam-UG/2021/909 dated 01/12/2021, all the Under-Graduate Examinations (Regular and Repeat) of General Education and under the Faculty of Education offered in the Affiliated Colleges commencing from 14th January 2022, **except the Final Year Examinations**, shall be conducted in **ONLINE** mode, as per the following guidelines:

- Pursuant to Goa Government directives all pending ISAs shall be conducted in Online Mode.
 The Semester End Examinations shall be conducted from 14 January 2022 onwards.
- 2. The duration of the Semester End Assessment/Semester End Examination and the maximum marks allotted for each Course shall be as per the relevant Ordinances.
- 3. The Practical Component of all the Examinations shall be conducted Offline mode.
- 4. For the Online Examination, the question paper shall be made available to the students through a variety of platforms. The students shall be given 30 minutes to download the Question Paper and 30 minutes to upload the Answer Paper. Students shall write down the answers and then scan/photograph and upload and submit the hand written answer sheet as instructed by the respective College. All typed answer sheets shall not be assessed.
- The Final Year Semester End Examinations shall be conducted in OFFLINE/ PHYSICAL MODE as per above mentioned Circulars.
- 6. The Final Year Semester End Examinations and all Practicals shall be conducted following all SOPS for Covid 19 Prevention including social distancing, sanitization of classrooms and using all other necessary precautions (facial masks, sanitizers etc.) shall be adopted as per Covid-19 prevention norms.

Principals of Affiliated Colleges of General Education and under Faculty of Education offering Under-Graduate Programmes are requested to take note of the same and bring the contents of the Circular to the notice of all concerned.
