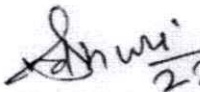

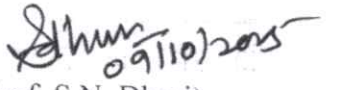

Instructions to Chairperson/Paper Setter/Examiner

The Principal of the College is informed to bring the following to the notice of their Faculty members:

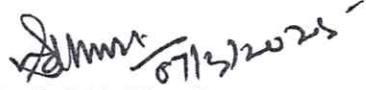
1. That the statutory provisions of the University as well as the Goa Prevention of Malpractices at University, Board and other Specified Examinations Act (Goa Act No. 8 of 1991), clearly states that examination work is an integral part of a teacher's duty and declining such important task shall be viewed seriously and shall also be punishable under the law (copy enclosed).
2. Study/Sabbatical leave: If the Research Institute, where the faculty member is carrying out research during the sabbatical leave/study leave, is within Goa, one has to participate in examination related duties, as salary is paid during this period. However, if the study is carried out in an Institute outside Goa/the country, the faculty member is exempted from such duties.
3. That no examiner will be excused citing any additional responsibilities assigned by the parent organization/any external body.

That the examiner can be excused, only as per the below mentioned cases:

- a. On health grounds, only based on the latest medical certificate issued by District Hospital/Goa Medical College and Hospital and forwarded through the Principal. The Principal while forwarding the application must ensure that the concerned faculty is on Medical Leave during the mentioned period and the dates be specified by the Principal.
- b. Not teaching the paper is not an excuse. Even if the faculty member is not teaching a course in the academic year, if it is a Core course, the faculty is bound to do the duty assigned. Exemption is applicable only in the case of Specialized/Elective Course.
- c. Those who are on deputation are exempted.
- d. Any other case forwarded by the Principal will be considered by the University authorities on case to case basis.

The request of the Faculty to exempt from the University examination duty must be routed through the Principal with his/her comments and recommendations.

This is issued with the approval of the Vice Chancellor.

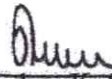
However, it has been observed that the **R&D Cell Coordinators** are frequently changed, and in some cases, the entire team is replaced annually. This creates challenges in communication, continuity, and the effective implementation of research initiatives. Additionally, many colleges have not submitted updated lists of coordinators after such changes, further complicating coordination. The issue is particularly concerning when contractual faculty members are appointed as **R&D Cell Coordinators**, as their tenure is limited to one year, leading to frequent disruptions.

To ensure stability and continuity in R&D activities, all institutions are hereby directed to **adhere to the following guidelines** while appointing and maintaining R&D Cell teams:

1. **Minimum Tenure:** Each R&D Cell Coordinator must serve for a minimum period of **three years** to ensure consistency in research initiatives.
2. **Team Stability:** The same team can be **extended beyond three years** if deemed necessary for institutional progress.
3. **Regular Updates:** Colleges must **immediately notify the Directorate of Higher Education of any changes in the R&D Cell Coordinator or team members**. Updated details should be submitted at the beginning of each academic year.
4. **Permanent/Regular Faculty as Coordinators:** To maintain continuity, institutions must prioritize the appointment of **regular faculty members** as R&D Cell Coordinators instead of contractual faculty whose tenure is limited.

All the Principals and the Heads of Institutions are requested to ensure strict compliance with these guidelines and submit an updated list of R&D Cell Coordinators along with names of team members by **15th April 2025** to the Directorate of Higher Education.

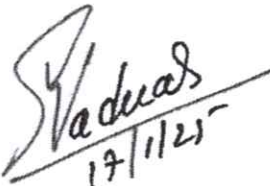

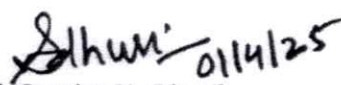

The date of eligibility shall be retained as the date of promotion. On the date of submission of the application, the candidate should fulfil all eligibility criteria required for promotion.

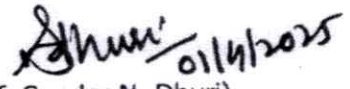
