FEES

One time Registration fee is collected at the time of provisional admission given to eligible students, which is non-refundable.

Course fee is to be paid in full at the time of admission.

On completion of the course, Caution Deposit received from the student will be refunded in full subject to "NO DUES" through Account Payee cheque within 30 days from the date of submission of the application for the same.

PAYMENTS

LATE FEES

If a student fails to make the payment of fees at admission time, or within the stipulated date, an email/ letter in the form of reminder (within one week) will be sent to the parent fixing an appropriate deadline date for payment of fees, which will not exceed more than two weeks.

On lapse of the deadline of due date, the student will attract the following fine.

CANCELLATION AND REFUND POLICY

Tuition fee and other fees shall be refunded to the student only after acceptance of application for withdrawal/ cancellation of admission from the course. Amount shall be refunded after retaining Administrative charges as per the slab given below, or as decided by Goa University from time to time. However, refund will not include fees received towards contribution to Student Aid Fund, special fee if any and university enrolment fee (if deposited with Goa University).

- 1. Caution deposit shall be refunded in full.
- 2. In case of (1) in the table above, 5% of the fees paid by the student subject to a maximum of Rs. 5000/- shall be deducted as processing charges from the refundable amount.
- 3. Refund to the applicant/ student will be made within 15 days from the date of receiving a written application from him/her in this regard.
- 4. Refund of fees will be made by Account Payee cheque only.
- 5. Acknowledgement will be obtained from the student/ Parent/Guardian for the amount that will be refunded to them.

EXPULSION

Constant violation of rules and regulations of the Institute, or hostel rules, by a student, may lead to expulsion of the student from the institute. In the event of an expulsion, there will be no refund of fees or refund of Caution deposit.
